What Does D.20-08-006 Authorize for San Gabriel?

Increases in Operating Costs in the Following Areas Required Increases in Utility Revenue to be Recovered in Rates:

Infrastructure Investments

- Main Replacement
- Reservoir Construction & Maintenance
- Plant Improvement
- Water Treatment Facilities

Operation Expense Increases

- Outside Services
- Payroll
 - Four new positions added
- Purchased Water & Assessments

Cost Increases Required the Following Increase in Utility Revenue for the Period 2018-2020:

- 2020/2021: \$4.3 million (5.9%) above authorized 2019-2020 revenues
- 2021/2022*: \$4.4 million (5.4%) above proposed 2020-2021 revenues
- 2022/2023*: \$2.2 million (2.6%) above proposed 2021-2022 revenues

*Revenue increases for 2021-2022 and 2022-2023 are estimated using an escalation procedure and inflation factors. Actual increases may vary based on most recent inflation forecast at the time of escalation.

Fontana Division's 2020-2021 Revenue to be Recovered in Rates: \$77,593,597

Increased Facilities Fees for 1" Meter and Larger¹ Recovery and Refund of Balancing and Memorandum Accounts

- 12-month surcharge of \$0.2445 per ccf for recovery of six balancing accounts²
- One-time surcredit based on meter size for refund of six memorandum accounts:³

Excluding city tax, surcharges and refunds, an average residential customer with a 5/8inch meter using 15 ccf (1 ccf = 748 gallons) would see a monthly decrease in each bill from **\$64.86** in 2019/2020 to **\$68.48** in 2020/2021. The same bill is estimated to be **\$73.24** in 2021/2022 and **\$75.64** in 2022/2023, resulting in an overall **16.6%** rate increase over 3 years.
