Comments on final LCR and FCR	May 4		
Reply comments on LCR and FCR	May 11		
Proposed Decision	mid-May		
Final Decision	June 21		





## **Potential Options**

- Delay decision to July 12
  - Would allow for comments on LCR and FCR
  - Compressed time for contracting
- June 21 decision with deadband
  - Adopt draft LCR and FCR numbers
  - If the final numbers are within 5% of draft numbers they are adopted automatically
  - Impacted LSEs file advice letter requesting to switch to final numbers if final numbers are >5-10% different
  - Petition for Modification required for changes over 10%

#### Alignment of CPUC RA Hours and CAISO Availability Assessment Hours

Originally CPUC and CAISO adopted identical hours

Month	Hours
January – March, November, December	HE17 – HE21 (4:00 pm – 9:00 pm)
April – October	HE14 – HE18 (1:00 pm – 6:00 pm)

- CAISO adopted new hours for 2018 (4-9 pm year round) and has committed to annual assessment of peak hours
- Propose that CAISO AAH analysis be submitted with flexible capacity requirements study each year
- Parties submit comments
- Commission considers whether to adopt new RA hours
