Settlement Year 6 – Second Quarter Progress Report to California Public Utilities Commission Electric Vehicle Charging Station Project

For the period March 6, 2018 through June 5, 2018 (the Reporting Period) Submitted July 5, 2018 by NRG Energy, Inc. on behalf of the Dynegy Parties¹

EXECUTIVE SUMMARY

NRG and EVgo continue to implement the settlement agreement to enable electric vehicle (EV) deployment in California through the installation of charging infrastructure across the state. In conjunction with the CPUC, the program has spurred a growing EV ecosystem that likely would not have been possible without this partnership. In this quarter, 253,055 fast charging sessions were delivered in the quarter, a 21% increase from Q1 2018. These sessions delivered 3,688,342 kWh of electricity, a 32% increase from Q1 2018.

As of June 5, 2018, (the Reporting Date), EVgo had a total of 211 Freedom Station sites either constructed or under development in the settlement service territory. Of these, EVgo has 200 qualifying Freedom Stations in operation. Among those, 21% are located in qualified low-income areas (by income-ranked PUMA), exceeding the 20% commitment, and serving a broad demographic range at places they prefer to shop, meet, and relax locally, including grocery stores, shopping centers, and malls.

During the reporting period, EVgo also made significant upgrades to Freedom Stations by replacing single-plug standard chargers with dual-standard chargers that include both CHAdeMO and CCS Combo connector which will have a measurable impact by expanding access to drivers to include the CCS charging standard.

EVgo continues to work towards meeting its regional targets with sixteen (16) Freedom Stations remaining to be installed in the LA Basin and one additional site to be installed in San Diego. With four (4) Freedom Stations in the permitting process, and active contract negotiations underway with site hosts in those regions, EVgo is expeditiously working through the development process to complete the settlement targets, including those in low-income qualified areas.

EVgo has made significant advances in the development of high power charging plazas (HPCPs) which are designed to benefit communities with high multifamily housing population density. Three sites in Northern California have progressed to an executed contract. As of the Reporting date, a fourth contract was signed. Subsequent to the reporting date, a number of additional HPCP projects went to contract. Additionally, EVgo has solicited research proposals to develop a study to measure and review their deployment.

EVgo and NRG are in compliance with the Make-Readies volumetric building requirement at this time. Overall, EVgo has 817 Make-Readies Sites under contract, representing 6,786 Make-Ready Stubs. Of these, 5,969 Make-Ready Stubs have been installed at 706 sites. Eighty-one (81) of these Make-Ready Stubs were added in the previous quarter. EVgo anticipates completing the construction queue later this year.

All Technology Demonstration funds have been allocated, and the three projects are underway. Specific updates for Technology and Opportunity Projects are provided below.

INSTALLATION OF PUBLIC EV CHARGING STATIONS (FREEDOM STATIONS)

During the Reporting Date, a total of 211 Freedom Station sites were either completed, under construction, or in development.

The table below summarizes Freedom Station progress throughout the term of the Agreement:

During the Reporting Period, no additional Freedom Stations were completed, however, upgrades to Settlement stations were completed which will have an immediate and measurable improvement of the accessibility and the user experience. Completed Freedom Stations are listed in Appendix A.

Station Upgrades

Early development of (two charger) Freedom Stations included deployment of Nissan DC Quick Charge machines which are only able to charge vehicles on the CHAdeMO protocol. Reflective of EVgo's commitment to enabling broad market development and growing capacity, EVgo identified stations in its network with high customer-demand yet limited by the CHAdeMO-only DC Fast Charger. In the past quarter, EVgo funded and completed the replacement of 18 of its CHAdeMO-only fast chargers with dual-standard (CHAdeMO and CCS Combo) fast chargers. A further 3 swaps are planned to be complete by the reporting date of July 5th, resulting in a total of 21 swaps. The swaps were conducted over the course of 45 days with no station being offline for more than 2 days and occurred in the metro areas of San Francisco, Los Angeles, and San Diego. This upgrade will result in greater charger availability, reduction of wait times, and a more

equitable experience for drivers of either fast charging standard. The complete list of sites with DCQC swaps are listed in the table below.

In concert with the Nissan DC Quick Charge swaps, EVgo is also improving the user experience by retrofitting machines with on-unit credit card readers. EVgo originally deployed a separate credit card kiosk at its stations to allow for single use payments across multiple different types of deployed DC fast charging machines. For example, the original Nissan DC Quick Charge did not have a native credit card reader option, and the ABB Terra 53CJ had a credit card reader that came optional but was not necessary as long as the separate credit card kiosk was already being utilized.

EVgo found that the separate credit card kiosk caused user confusion, and customers have expressed a desire for on-unit credit card readers. With the removal of the Nissan DC Quick Charge machines, EVgo has begun retrofitting the ABB Terra 53CJ DC fast chargers with on-unit credit card readers from the manufacturer Nayax.

This retrofit program is aimed at increasing the ease and access of single-use charging sessions on our public network of chargers associated with CPUC settlement sites. The credit card reader retrofits have started in Q2 2018 and are expected to continue through the end of Q4 2018 and will be funded through CPUC settlement funds.

Station Distribution

The Agreement requires a minimum number of Freedom Stations in each of four geographic regions. The table below summarizes the geographic distribution requirements and progress as of the Reporting Date.

As seen in the preceding table, the Minimum Freedom Station Count has been fully met or exceeded in the SF Bay Area and the San Joaquin Valley. Current exceedances will contribute to meeting requirements of the anticipated Freedom Station Savings event.

Site Development

During the Reporting Period, EVgo can report that four (4) Freedom Stations in LA Basin are in the permitting phase. To meet regional requirements in LA Basin (16) and San Diego (1), EVgo is in active contract negotiations with site hosts, several of which include multi-site agreements. EVgo continues to evaluate its sales pipeline to expedite the site development process by initiating the utility application and permitting process. This will abbreviate the time-frame between sites moving from an executed contract to the construction phase of the project. EVgo is on pace to have secured contracts and construction underway on the remaining sites by the December 2018 deadline.

Based on current projections, EVgo anticipates having a Freedom Station Savings Event (as defined in the Agreement) with the same budget for 200 Freedom Stations and has begun site planning of additional Freedom Station as required, with seven (7) sites under contracts in the SF Bay Area and additional sites in negotiations across multiple geographies. While EVgo continues to pursue the development of stations for the Savings Event, these sites are not being prioritized over our requisite station requirements in LA Basin and San Diego.

Low-Income PUMA Distribution

Forty-two of the 200 fully operational Freedom Stations are in low-income PUMAs: 16 in the San Francisco Bay Area, 18 in the Los Angeles Basin, 4 in San Diego County, and 4 in the San Joaquin Valley. They represent 21% of all operational sites, exceeding the goal of 20% in this

category. The table below summarizes the low-income PUMA distribution and progress as of the Reporting Date.

EVgo is prioritizing the development of the four outstanding PUMA qualified sites in the LA Basin. Currently, three sites that are in active contract negotiations in the LA Basin are PUMA qualified.

Assessing Freedom Station distribution by income classification of PUMAs is a device that CPUC and NRG developed for the settlement agreement because no other standards existed at the time. Since then, the Office of Environmental Health Hazard Assessment (OEHHA), on behalf of the California Environmental Protection Agency (CalEPA), developed the California Communities Environmental Health Screening Tool. CalEnviroScreen is a screening methodology that can be used to help identify California communities that are disproportionately burdened by multiple sources of pollution. CalEPA has used the tool to designate California communities as disadvantaged pursuant to Senate Bill 535.

Applying CalEnviroScreen to the Freedom Station distribution for information purposes, as requested by CPUC, shows nearly the same number of qualifying sites (43 out of 200), with a slightly different distribution than the PUMA communities. NRG and EVgo will continue to assess the distribution by this standard in coming reports to align the state's environmental justice standards with the settlement infrastructure.

INSTALLATION OF HIGH POWER CHARGING PLAZAS (HPCP)

As part of the Second Amendment to the Long-Term Contract Settlement, EVgo is committed to building ten (10) charging plazas to serve the charging needs of residents of multi-family housing.

These charging plazas will meet the following criteria:

- At least three (3) 50kW (or higher) DC Fast Chargers
- Support both the CHAdeMO and SAE Standard
- Located in the top 50% of California Public Use Microdata Areas (PUMAs) ranked by percentage of residents in multi-family housing
- Distributed with a goal to serve drivers throughout the State of California, including in both Northern and Southern California

These stations shall be distributed throughout the State of California, including 20% of stations installed in qualified low-income areas (by income-ranked PUMA).

As of the Reporting Date, EVgo has executed contracts for three (3) high power charging plazas in Northern California, with one of these sites progressing to permitting. EVgo is in active contract negotiations, targeting sites in Los Angeles Basin and San Diego County to balance the distribution of sites in the State.

During the reporting period, EVgo began solicitation for research proposals to evaluate the extent to which these charging plazas are serving the multi-family segment as intended. This study is planned to commence following the energization of the first charging plaza.

HPCP Progress Distribution

The table below summarizes the geographic distribution and progress as of the Reporting Date While the distribution of the HPCPs differ from that of the Freedom Stations, the geographically defined territories for the (LA basin, SF Bay Area, San Joaquin Valley and San Diego county) has been applied to demonstrate the station distribution. The geographic distribution of HPCP is aimed to serve drivers throughout the State of California, including in both Northern and Southern California.

Low-Income PUMA Distribution

One of the HPCP sites under contract is located within the low-income PUMA. There are additional sites within EVgo's pipeline to deliver the minimum PUMA qualified sites (2).

INSTALLATION OF MAKE READY STUBS AND MAKE READY ARRAYS

Status of Make-Readies Sites

Overall, EVgo has 817 Make-Readies Sites under contract, representing 6,786 Make-Ready Stubs. Of these, 5,969 Make-Ready Stubs have been installed at 706 sites, as set forth in Appendix B.

NRG and EVgo have had success in reaching disadvantaged communities with this program. For information purposes, CPUC staff requested an analysis of distribution based on the CalEnviroScreen (CES) standard, which did not exist at the time the settlement was enacted. The distribution is reported in the chart below.

Another way to consider make-readies distribution to disadvantaged communities or residents is to consider the percentage of multi-dwelling unit (MDU) properties (and stubs) that have deed-restricted housing units. By this standard, the results benefit disadvantage communities at 29.0% of total operational MDU stubs. This is due in part to inclusionary housing requirements in many California communities, where mixed-income housing in single properties is a norm. Thus, residents of low-income housing units as measured by the median income in the region have reasonable access to the stubs built in this program. That being said, NRG and EVgo have found that a large number of low-income Californians do not have access to regular off-street parking; accordingly, public fast charging remains a critical priority for expanding EV access across demographics.

USAGE DATA

EVgo completed 253,055 fast-charging sessions in the Reporting Period at Freedom Station sites and dispensed over 3,688,342 kilowatt-hours of electricity.

This translates to 11.5 million miles driven on electricity in this quarter, displacing 474,324 gallons of gasoline (assuming 3.125 miles per kWh and 24.3 mpg).³

TECHNOLOGY DEMONSTRATION PROGRAMS

Stationary Storage Plus Electric Charging (SSPEC)

Project Background

The Stationary Storage Plus Electric Charging (SSPEC) project uses stationary batteries in a technology demonstration application to reduce the cost of operating DC fast chargers (Level 3) and alleviate strain on the grid.

The SSPEC project has successfully:

- 1. Deployed a test site with microgrid components, including battery storage, solar generation, EV charging infrastructure, and site control technology.
- 2. Tested various configurations of distributed energy resources and electric vehicle DC fast chargers.
- 3. Analyzed results from operation of the SSPEC site and historical data from EVgo's charging station network to identify load profiles, potential sites, and utility territories which can benefit most from stationary storage and/or generation on site.

Upon successful economic and operational demonstration, EVgo intends to commercialize these technologies and integrate them into its broader DC fast charger network as appropriate.

The SSPEC work will enable improved deployment of DC fast chargers by EVgo and third parties at a wider variety of locations. Stations deployed with stationary storage can have a lower total cost of ownership to property owners and electric vehicle service providers (EVSPs) alike.

Previous Quarter Activities

In Q2, EVgo's energy storage system at Union City completed controls integration between Princeton Power, BMW, and Kisensum site controller. The energy storage device is programmed to keep site demand below 75 kW and allow EVgo to stay on PG&E's A6 Tariff. A third charger was turned on at SSPEC site and Spiers New Technology completed data collection report on Second Life battery stack.

EV Storage Accelerator (EVSA)

Project Summary

The EV Storage Accelerator (EVSA) aims to demonstrate vehicle-to-grid (V2G) technology as a low-cost energy storage resource. The project will use nine vehicles for the demonstration, three Honda Accord Plug-in Hybrid electric vehicles (PHEV) and six Nissan LEAF battery electric vehicles (BEV). The four primary goals of EVSA are:

- Create a test environment for two major automakers, Nissan and Honda, to gain experience with V2G technologies and prepare them for a further commitment to the technology.
- Advance product readiness for bidirectional inverters, including listing standards and product certification.
- Identify use cases for V2G and test vehicles against those use cases.
- Inform public policy around the system, ratepayer and customer benefits of V2G.

For a more detailed report on the scope of work and related activities, please refer to the Final Scope of work – October 2015 as well as the Revised EVSA Scope of Work – April 2018.

Previous Quarter Activities

Use Cases: The EVSA Project Team continued to work on executing the outlined use cases. The first use case, Interconnection, was executed in full on April 24th, upon receipt of the permission to operate the bi-directional Princeton Power station at UCSD's Trade Street from San Diego Gas & Electric.

The second use case, Transformer Upgrade Deferral, designed, installed and commissioned the hardware and software systems in March and April and begun the outlined testing procedures in May. The installation process included the re-routing of the solar PV array from EVgo's SSPEC site at UCSD to the charging island where the use case's EVSEs were being installed. The goal is to have the vehicles respond to the solar generation in real time – either charging during times of high generation or discharging during times of low generation. The testing and data collection will conclude by the end of June and results will be incorporated into a final report that will be sent to both the California Energy Commission and the California Public Utilities Commission. The site is expected to be decommissioned by the end of July, restoring the SSPEC site's solar array to its original configuration.

The third use case, Emergency Power Back-Up, continued to be put on hold in Q2 to focus on pushing forward the project-critical technical integration required to implement the fourth use case described below. The Project Team anticipates revisiting the implementation of this use case in early Q3 2018 to finalize an implementation plan with stakeholders to be executed in early Q4.

The value of V2G use case continued to make progress in Q2. All 8 of the project vehicles were successfully executing vehicle-to-grid responses based on signals sent from the Nuvve aggregator. After a year of searching for a frequency regulation signal (aka the California Independent System Operators (CAISO) Automated Generation Control (AGC) signal), the Project Team secured a historical signal recorded from the Los Angeles Air Force Base VGI project which bid into CAISO's Ancillary Services – Frequency Regulation market in 2016 and 2017. This signal is largely considered the best option available to the EVSA project in order to simulate the project vehicles' participation in the market with the goal of leveraging the response data to quantify the potential value to be earned from responding to the signals. Energy and Environmental Economics, Inc. ("E3") was brought on as a subcontractor to lead the quantification efforts and produce key portions of the interim and final project reports.

Deliverables: The Project Team submitted the following deliverables in confidential Appendix D-2 of the Q2 2018 quarterly report: (1) Charging Station Metrics Report. The other deliverables due this term (Interim Report on Actual and Simulated Revenue from V2G, Interim Data Analysis Report Module and Interim Project Benefits Update) will be submitted to the CPUC following detailed internal review at the beginning of July. This is due to the need to have a full monthly data set from June for comparison purposes.

Administrative: The EVSA Project Team submitted a revised Scope of Work for the EVSA project to the CPUC in Q1 2018 and it was approved on May 9, 2018 by the CPUC Executive Director.

Subsequent Quarter Activities

The majority of the significant hurdles the EVSA project faced have been resolved over the past six months, therefore the next quarter will be focused on fine-tuning the operation of the hardware and software and ensuring data quality to inform E3's quantitative analysis. Additionally, the Project Team will wrap up Use Case #2, finalize the testing and data collection protocols and cost-benefit analysis procedure for Use Case #3, and start to outline the final project deliverables. There are no deliverables due at the end of Q3 2018 with the exception of the quarterly Charging Station Metric Report.

Extreme High Power DC Charging Station

Project Background

Automakers are continuing to increase range of EVs by increasing battery capacities, e.g. the late-2016 release of the all-electric Chevy Bolt with 238 miles of range and announcements of soon-to-be-released vehicles of similar and longer range. To maintain a consistent customer / EV driver experience regarding charge duration and SOC (State of Charge) completion percentage, DC EVSE infrastructure will likely increase the power level of charging infrastructure (i.e. increase the rate at which energy is delivered into the electric vehicle battery).

This project is intended to bring auto OEMs, EVSE, and cable manufacturers together to demonstrate and facilitate testing and development of standards and equipment. The project will do the following:

- Deploy first of its kind EVSE infrastructure capable of high-power DC charging (300+ amps).
- Test with auto OEMs and EVSE providers to allow for test bed and development of standards.

Previous Quarter Activities

EVgo's high-power charging station in Baker, CA became operational in Q2 2018 The site's construction is 100% complete and received utility energization from Southern California Edison on May 23rd, 2018. The (2) 50 kW chargers at the station were commissioned on June 15, 2018 and the site is open for public charging as of June 22, 2018.

EV OPPORTUNITY PROJECTS

The EV Opportunity Program under the Agreement consists of \$4 million toward "...Enhancing the appreciation of the social benefits of electric vehicles and creating opportunities for residents of underserved communities to benefit from expanded use of electric vehicles." More specifically, the EV Opportunity Program Amount may be used to fund: a) the deployment of electric vehicle charging infrastructure to support electric vehicle car-sharing projects, in particular in low-income areas within the State of California; b) an EV job training program; and c) other projects consistent with the objectives of Section 4(d)(ii) of the Agreement.

The two approved Opportunity Programs, Green Raiteros and Electric Access Charging Hub (EACH), were established in 2017. Summaries of these programs, progress to date, and ongoing project schedules are included herein.

Green Raiteros

Project Background

The Green Raiteros Pilot Project is being executed in partnership with the San Joaquin Valley Latino Equity Advocacy & Policy Institute (the LEAP Institute), the Fresno County Rural Transit Authority (FCRTA), the Shared Use Mobility Center (SUMC), and West Hills Community College. The Green Raiteros Pilot builds on an existing grassroots ridesharing program. The Raiteros, are retired Valley farmworkers who offer rides for people without access to transportation to and from work. Green Raiteros expands access to carbon-free mobility in the Central Valley by strategically and sustainably introducing EVs to the Raiteros' services. EVgo worked with the LEAP Institute to apply for the 11th Hour Project Just Transit Challenge, a fund dedicated to reducing emissions while increasing equitable transportation options. This funding was awarded in Q2 2017 and will be used to acquire two EVs, a 2018 Chevy Bolt and a used BMW i3s for the Green Raiteros Pilot Program.

In 2017 accomplishments for Green Raiteros included: executing the program kickoff; forming a stakeholder advisory committee; establishing the LEAP Institute non-profit business status to manage Green Raiteros; and focusing the pilot program on infrastructure and business capacity expansion. For the 18-month period of support provided by EVgo's settlement with the CPUC, the LEAP Institute will administer budget items pertaining to staff hiring and business model development, establishing a sustainable business plan that allows for ongoing funding and support from outside sources. Green Raiteros has worked to identify future funding sources; With a competitive proposal submitted to the Fresno Transformative Climate Communities, a project administered through the Strategic Growth Council, the Clean Shared Mobility Network will provide for ten additional carshare stations, including a minimum of 5 level 2 and level 3 chargers each, and 42 electric vehicles that will be leveraged to expand existing Green Raiteros'

service in 2019. This proposal aims to enhance electrification and shared mobility strategies in Fresno and will be funded at over \$9 million. Q1 2018 operational development included a finalized business plan submitted by SUMC, hiring of first Green Raiteros Operations Manager, multiple advisory committee meetings with update reporting, fully executed lease, executed construction contracts and driver engagement.

Previous Quarter Activities

Q2 saw remodel construction break ground for the Green Raiteros Headquarters, engagement of PG&E for expanded service at headquarters, and new driver orientation in Huron with CalVIVA Health Net. Additionally, in Q2 Fresno Council of Governments was engaged for programmatic review of existing transportation programs in county and a public relations firm is under contract for ribbon cutting event and recruitment outreach. App developers are under review and EVSE suppliers have submitted proposals. Additional non-profits are actively engaged such as The Center for Energy Efficiency and Renewable Technologies, Just Transit and The California Endowment for additional funding opportunities. Monthly advisory meetings have regular attendance and the office computer system and bank account have been set up.

As of the Reporting Date, the Leap Institute received their notice of their 501(C)(3) exempt status.

EACH

Project Background

The focus of the Electric Access Charging Hub (EACH) project is to create EV access and job opportunities to underserved communities. EVgo is developing seven EV-charging hubs in low-income communities of the San Francisco Bay Area, Los Angeles, and San Diego that will serve the public as well as electric carshare vehicles. The EACH project aims to support EV carsharing and ridesharing, create job opportunities, provide publicly available EV fast charging, and spur the adoption of electric vehicles in underserved neighborhoods.

In 2017, EVgo engaged in preliminary partnership and site development discussions with entities including: the city of San Francisco, the city of Oakland, the city of Richmond, Los Angeles Department of Transportation, Los Angeles County Metropolitan Transportation Authority, and Grid Alternatives. In 2017 accomplishments for EACH included: increased engagement from project advisor the Shared-Use Mobility Center (SUMC) and proposed formation of partnerships with the Center for Sustainable Energy (CSE) to oversee marketing and outreach strategies, coordinate with community-based organizations and local nonprofits, and conduct program evaluation. In 2018 Q1 the proposed partnership with CSE dissolved due to CSE expanded workload with other programs. SUMC increased engagement in EACH project administration, working to identify potential partners and connect EVgo with additional site identification in all three regions. This work culminated in a state of the industry memo to EVgo, highlighting recommendations on carshare partnership models and site suitability, a synthesis of findings from stakeholder interviews, and potential alignment with additional funding sources.

Previous Quarter Activities

In the past quarter, EVgo and SUMC identified and made initial contact with community-based organization (CBO) to develop the underpinning for stakeholder engagement and potential non-profit partnerships for EACH hubs. EVgo will build on these conversations and use the feedback from CBOs better define the scope for the marketing and educational outreach paired with the launch of an EACH hub.

EVgo began solicitation for research proposals to prepare for the evaluation of the EACH program. A research partner will help define the key performance indicators, used as a basis for evaluation as well as address the three main questions:

- How much the project improves accessibility to electric vehicles and electric vehicle services?
- What are the direct environmental impact of GHG reduction?
- What are secondary effects on vehicle ownership mobility and unemployment?
- developing KPIs for which to evaluate and This study is planned to commence following the energization of the first charging plaza.

EVgo has continued to move sites forward in the development process with all 7 potential locations in the proposal phase. In the last quarter EVgo responded to a formal RFP to develop a hub and awaits final confirmation of the award status, anticipated Q3 2018. Final confirmation of the sites will ensure that marketing, education and partnership outreach will reach the right audience to promote the utilization and social benefit of the hubs.
