AUDIT SUMMARY

1.	Location:	Orion service territory
	Date of CPUC Inspection:	8/19/2013

Explanation of Violation(s):

Incomplete Patrols

GO 95, Rule 80.1-A1, States in part:

In high fire-threat areas, the inspection intervals for (i) Communication Lines located on Joint Use Poles (See Rule 21.8) that contain Supply Circuits (See Rule 20.6-D), and (ii) Communication Lines attached to a pole that is within three spans of a Joint Use Pole with Supply Circuits, shall not exceed the time specified in the following Table.

Orion did not have records showing that it patrolled all of its facilities in high fire areas in 2012. Orion indicated that it patrols its facilities in the course of other work, such as during service installations. However, as Orion does not record these patrols, Orion is unable to verify that it patrolled all of its facilities.

Incomplete Records

GO 95, Rule 80.1-A4, States in part:

Each company shall maintain records for at least ten (10) years that provide the following information for each facility subject to this rule: The location of the facility, the date of each inspection of the facility, the results of each inspection, the personnel who performed each inspection, the date and description of each corrective action, and the personnel who performed each corrective action.

Orion did not have records of all patrols completed in 2012 to satisfy Rule 80.1-A1. Orion indicated that while it patrols its facilities in the course of other work, it does not record these patrols.

Incomplete Detailed Inspections

GO 95, Rule 31.2: Inspection of Lines, States in part:

Lines shall be inspected frequently and thoroughly for the purpose of insuring that they are in good condition so as to conform with these rules.

Orion did not have records showing that all Orion facilities were patrolled and inspected prior to 2012 to satisfy the requirements of GO 95, Rule 31.2. Orion indicated that while it patrols and inspects its facilities in the course of other work, it does not record these patrols or inspections.

The following violations were not documented and/or addressed by Orion during its patrols and inspections as required by General Order 95:

Damaged Ground Molding

GO 95, Rule 84.6-B: Ground Wires, States in part:

Ground wires, other than lightning protection wires not attached to equipment or ground wires on grounded structures, shall be covered by metal pipe or suitable covering of wood or metal, or of plastic conduit material as specified in Rule 22.8-A, for a distance above ground sufficient to protect against mechanical injury, but in no case shall distance be less than 7 feet.

An Orion plastic ground covering, within seven feet from the ground, was found damaged. The violation was not documented when Orion last inspected the pole.

No communications conductor, cable or messenger shall be supported on or attached to the top or side surface of any guard arm as permitted for service drops and their (vertical and lateral) runs by provisions of Rules 84.6-C and 84.8-B2c.

An Orion cable was attached to the top of a guard arm. The violation was not documented when Orion last inspected the pole.
