III. Field Inspection - Violations

We observed the following violations during the field inspection. These violations were not documented and/or addressed by Comcast during its last inspections:

GO 95, Rule 38, Table 2, case 16C, requires service drops to have a minimum 3 inch clearance from other communication lines.

Comcast service drops at the following locations were less than 3 inches from other communication lines:

- 1491 37th Ave.
- 227 27th Ave.

GO 95, Rule 84.8D(4) – **Clearances between Conductors**, requires service drops to have a minimum 12 inches of radial clearance from electric supply service drops within 15 feet of attachment to a building.

Comcast service drops at the following locations had less than 12 inches separation from electric supply service drops:

- 131 27th Ave.
- 156 27th Ave.
- 166 27th Ave.
- 966 Minnesota St.
- 3653 20th St.

GO 95, Rule 37 – Minimum Clearances of Wires above Railroads, Thoroughfares, Buildings, Etc., requires the clearance of communication conductors to be at least 18 feet above ground at the center of a public thoroughfare.

The overhead clearance of a Comcast service drop at the center of 346 Ashton Avenue was 17 feet.

GO 128, Rule 17.1 – Design, Construction, and Maintenance, states in part:

Electrical supply and communication systems shall be designed, constructed, and maintained for their intended use, regard being given to the conditions under which they are to be operated, to enable the furnishing of safe, proper, and adequate service.

Comcast handhole covers at the following locations were damaged and could not be lifted by hooks:

- 3168 Mission St.
- 3184 Mission St.
- 3189 Mission St.

A Comcast wall mounted box at 731 Bay St. did not have a cover.
