CPUC Names Acting Executive Director

Rachel Peterson, who has served in a variety of leadership positions during her nine years at the California Public Utilities Commission (CPUC), was named Acting Executive Director on Sept. 4, 2020.

Rachel had been serving as the CPUC's Deputy Executive Director for Safety Enforcement and Policy.

"My fellow Commissioners and I are grateful for, and encouraged by, Rachel's willingness to serve in this role," CPUC President Marybel Batjer wrote in an email to CPUC staff. "Rachel is a proven policy and organizational management leader. We look forward to working with Rachel in leading the CPUC forward."

Rachel has experience in numerous areas of the CPUC's utility regulation, including electricity, natural gas, safety, and transportation, and has led initiatives to bring greater transparency to the CPUC's processes. She has also been an Advisor to Commissioners, Chief of Staff to Commissioner Liane M. Randolph, and Acting Director of the CPUC's Safety Policy Division.

Rachel is an attorney and former nonprofit Executive Director, and lives in the San Francisco Bay Area with her family. She earned her law degree from the University of California, Berkeley School of Law and her bachelor's degree from Columbia University, where she majored in anthropology. "I joined the CPUC in 2011 because I was motivated by its mission to achieve climate-related energy goals, and then as I gained experience in other areas of the CPUC's regulation, such as safety and transportation, I found those equally rewarding," said Rachel. "My goal is to provide stability to the CPUC while encouraging all staff to continue meeting the CPUC's high standard of excellence in our programs."

President Batjer also announced on Sept. 4 that Michelle Cooke, an Assistant Chief Administrative Law Judge, will take up the role of Acting Deputy Executive Director for Administrative Services.

"Both Rachel and Michelle were asked to take on these responsibilities, and I have committed to each of them my full support and confidence," President Batjer said in her email to CPUC staff announcing the moves. "There is so much important work before us, and I have full confidence that we can continue, as a team, to deliver for the people of California."

Remembering the 2010 PG&E Pipeline Tragedy in San Bruno

Commissioners and staff at the CPUC took time on Sept. 9 to mark the 10th anniversary of a Pacific Gas and Electric Company (PG&E) pipeline explosion in San Bruno, honoring the victims and reflecting on safety related changes made following the tragedy.

The blast took eight lives—including longtime CPUC employee Jacqueline Greig and her teenage daughter, Janessa—injured 58 people, destroyed 38 homes, and damaged 70 more.

Federal regulators investigating the tragedy cited poor record keeping by PG&E and lax oversight by the CPUC as major contributors to the disaster.

CPUC President Marybel Batjer noted at the solemn virtual commemoration to remember the tragedy that the CPUC is a much different organization a decade later.

"CPUC regulation and oversight has become more proactive through a multi-year, multi-billion-dollar pipeline safety testing and replacement program, increased staff citation authority, increased frequency of inspections, and the more than tripling of our staff of gas safety engineers," President Batjer said. "Our enhanced focus on safety has been an ongoing effort and has involved the hard work of scores of dedicated staff. While improvements and advancements cannot right the wrongs of the past, they can help ensure that similar tragedies do not occur in the future."

Two CPUC employees who knew Jacqueline Greig spoke warmly about their late colleague who had been an analyst in the CPUC's Division of Ratepayer Advocates, Natural Gas Section, responsible for analyzing PG&E's transmission system at the time of the explosion.

Wendy Al-Mukdad, a Senior Utilities Engineer who was friendly with Jacqueline and lived close by, recalled how the two busy working mothers had exchanged phone numbers but never found time for a trail walk they had talked about.

Dave Ashuckian, Deputy Director of the Division of Ratepayer Advocates at the time of the explosion, spoke about his late colleague who had recently traveled to Europe and loved all the cherry blossoms she saw. A group of CPUC colleagues pitched in and erected a memorial bench and planted a weeping cherry tree in the CPUC courtyard in San Francisco to honor their colleague, but the tree did not fare well in the courtyard's microclimate. The bench and planter are in the northeast corner of the Courtyard.

Also speaking at the anniversary commemoration was Terence Eng, a Program Manager of the CPUC's Gas Safety and Reliability Branch, who went through some of the safety related practices adopted or strengthened at the CPUC over the past decade.

The anniversary of the tragedy was noted again the following morning during the CPUC's Voting Meeting with eloquent comments from State Senator Jerry Hill, whose district includes San Bruno.

After reading the names of the eight victims, he said, "(The) explosion and the corruption and criminality that was uncovered afterward did not and does not define my community. Rather, it strengthened us ... This drive to ensuring a tragedy like the San Bruno explosion never happens again was not mine alone or not even mine to begin with. This drive came from the citizens of San Bruno, the community that elected me to serve them ... It is that drive from my constituents that motivated me every day of my legislative career. And I know that it motivates many of you in your work at the Commission every day because you recognize the lives on the line with each decision you make. Hold that responsibility with the humility and gravity it deserves. That is what we remember today, the eight lives lost 10 years ago and the charge to honor their lives everyday by your actions. Never forget and never again."

CPUC Takes Steps to Help Close the Digital Divide

The CPUC, following up on an Executive Order issued by Governor Gavin Newsom in mid-August, has opened a new proceeding (called a Rulemaking) to explore how to close the state's digital divide and make sure Californians everywhere have quality, affordable Internet service.

Specifically, the <u>new Rulemaking</u> approved at the CPUC's Sept. 10 Voting Meeting seeks to "identify and implement strategies to effectively deploy quality, affordable, and reliable broadband to all Californians."

"Communities across California face a multitude of barriers for the deployment of resilient and accessible networks," noted the Rulemaking. "Broadband Internet access service in urban communities varies by neighborhood, with great discrepancies in infrastructure technology. Communities in rural areas often lack sufficient wireline and wireless broadband Internet access service, as well as the backhaul infrastructure to provide broadband services."

And those discrepancies have been made more acute by the COVID-19 pandemic and the fact that so many more people are working and attending school remotely. More Californians are telecommuting from their places of residence and millions of children are attending classes remotely. Additionally, with unprecedented growth in unemployment caused by COVID-19 and the need to participate in society from home, the demand for low-cost broadband Internet access service will increase as millions of additional Californians need affordable plans to get through the pandemic and recover.

Commissioner Martha Guzman Aceves, who is the lead Commissioner on the new proceeding, said federal rules and the assumption that competition would bring down prices and serve everyone are a big part of the problem.

"This neoliberalism economic theory has failed many Californians," she said. "In fact, 23 percent of California households do not have the Internet at home. That's leaving 8.4 million Californians digitally disadvantaged and unable to participate in

many of the benefits of economic and civic life, and this has to change. We all know this so intimately today as we take refuge in our homes, not only from COVID-19, but from the clouds of smoke and particulates that's spread across our state. The Internet has been able to save many jobs, many people's health, and our children's education. And every Californian, every neighborhood, needs the Internet to be resilient."

Plus, Commissioner Guzman Aceves said, competition among Internet providers is not nearly as robust as some may assume.

"Only a very small group of Californians have choices," she said. "Less than seven percent of Californians are served by three or more providers. About half of us have two choices, but over 40 percent have one or fewer if we even have service at all. There is not any area of the state where a cable company is competing with another cable company. If that cable company chooses not to serve all the residents in a community, there is no cable option. This is due once again to the federal construct and the lack of obligation to serve all Californians."

As currently envisioned, the proceeding will be organized around specific actions to further the Executive Order in the areas of:

- Infrastructure deployment models and strategies for universal service, so that every California home and business can connect to the Internet;
- Economic vitality and recovery; and,
- Strategies to support specific communities, public safety, and other critical issues.

Commissioner Guzman Aceves made a direct appeal for broad public engagement in the proceeding so the most innovative ideas and approaches can be identified, considered, and tried through pilot programs and a variety of new approaches, like partnering with regulated utilities.

GET TO KNOW US: Meet Desireah LaMar

Desireah LaMar, the CPUC's new Equal Employment Opportunity (EEO) Officer, is a strong proponent of culture and diversity.

Her first foray into the world of global culture and diversity occurred when she had the opportunity to study abroad in Paris for a semester her junior year at Saint Mary's College of California. Being immersed in a culture and country different from her own taught her self-reliance, flexibility, and empathy.

After a semester in Paris, Desireah returned to the U.S. with a strong interest in studying and immersing herself in cultures different from her own. So, then came the Peace Corps.

Spending time abroad can be life changing, and it was for Desireah. She served in Bulgaria, where she had an opportunity to be a primary and secondary school teacher—that was her interest when she signed up—and to learn the Bulgarian language.

"I learned a lot in Bulgaria about cultural differences, some large and some small," she said. "The country was communist for decades until about 15 years before my arrival, and I also learned that nodding your head back and forth means 'no' and shaking it means 'yes.' It really was a life-changing experience for me that I will always cherish."

After the Peace Corps, Desireah's interest in culture and diversity grew and she wanted to do more. She soon began a master's program in Intercultural Relations from University of the Pacific in Stockton while working full-time at the County of Sacramento, in support services, Organization Development and Administration.

Desireah said spending so much time abroad made her realize how much the world is "shrinking" and how companies that do business across nations interact, communicate, and work with each other. She also developed a deeper appreciation for the value of people with different backgrounds and from different countries being able to communicate and work effectively together.

As she finished her degree and worked for Sacramento County, she had the opportunity to serve on the Sacramento Metropolitan Arts Council's Racial Equity Task Force, which works to make art grants more equitable for artists of color. Once she completed her master's degree, she joined the State of California in 2017, working in CAL FIRE's EEO Office and creating the agency's first policy on diversity and inclusion.

Desireah then served as the EEO Officer for the California State Board of Equalization. She also serves on the California Statewide Diversity, Equity, and Inclusion Committee as a founding Steering Committee member, and regularly attends the California Civil Rights Officers' Council meetings. The two organizations provide guidance for employees working in the diversity and EEO fields and Desireah loves the opportunity to compare notes and best practices, as well as meet young professionals with the same commitment to making our workplaces more equitable and inclusive.

Desireah came to the CPUC in February, working in the Sacramento office for three weeks when the Governor's stay-at-home order was issued. New to the organization, working remotely has made it challenging getting to know staff and in staff getting to know her.

But Desireah has gladly put in the extra effort to become acquainted with her colleagues through virtual meet and greets, sending her bio to all staff, and participating in a New Employee Orientation each month.

"I read about the good work the Commission was doing with low-income customers and ratepayers," she said, "and the responses I got from my new colleagues were so quick and warm during the hiring process. It was a good feeling and I knew I had made the right choice in joining the

She continues to work on creative ways to connect with staff during these unusual times, by continuing meet and greets with Divisions, communicating virtually about cultural awareness issues and events, and attending employee committees and groups, such as the Disability Advisory Committee, the African American Coalition, and the Rainbow Regulators.

With so much happening in recent months concerning racial and civil injustice, Desireah feels fortunate to have joined the CPUC at a time when Commissioners and staff are doing a lot to advance diversity, equity, and inclusion in hiring and other areas.

Diversity, Equity, and Inclusion Working Group to make sure the CPUC advances diversity, equity, and inclusion for all of its staff. This includes taking a closer look at hiring and promotion practices to make sure implicit bias does not hinder anyone's advancement.

In addition to work being done by the new group, EEO and Sexual Harassment Prevention policies are being updated. Implicit Bias training has been conducted for all staff, making this an exciting time to be part of so many positive initiatives.

The CPUC has discussed the future of the communications grid in California for well over a year, with two public forums and other proceedings on affordability, resiliency, emergency disaster relief measures, and expansion of programs such as LifeLine that help low-income consumers pay for telecommunications service.

"It is so important to bridge the digital divide in our state," said Commissioner Genevieve Shiroma. "It has been very eye-opening for me to see the disparities as described by Commissioner Guzman Aceves in terms of the access or lack of access according to geographical gaps and some areas providing levels of broadband that are not sufficient for current needs."

President Marybel Batjer called the proceeding "so needed" and said she especially likes the focus on innovation, something also noted by Commissioner Liane M. Randolph, who said, "I really like the idea of taking a look at other jurisdictions and even other jurisdictions within our state and sort of picking those most creative and innovative ideas and figuring out if we can bring them to scale."

Commissioner Clifford Rechtschaffen also expressed support, calling the proceeding "incredibly timely given the COVID pandemic and the disparities that it's underscored. I very much support the broad and comprehensive view that this is going to take looking for new innovative models and, of course, the special focus on low-income communities, those in high fire-threat areas, and those with low broadband adoption rates. Very important issues that merit consideration in this dedicated proceeding."
