



EXECUTIVE SUMMARY

2018

Southwest Gas Corporation (Southwest Gas or Company) sustained its strong supplier diversity spend during 2018, and for the 13th consecutive year, surpassed the 21.5 percent minimum goal established by General Order (GO) 156 for procurement with California Clearinghouse-Verified diverse suppliers. In 2018, Southwest Gas achieved procurement results of \$32,243,423 with Clearinghouse-Verified diverse suppliers in support of our California operations, equal to 65% of the Company's total California procurement. In addition, Southwest Gas spent \$180,992,338 with Clearinghouse-Verified diverse suppliers in support of the Company's Arizona and Nevada operations, reflecting the importance of supplier diversity throughout our organization and multi-state service territories. Southwest Gas' Supplier Diversity Program 2018 results are summarized in the table below.

In addition, Southwest Gas' parent company, Southwest Gas Holdings, Inc., utilized two diverse investment banks as co-managers in a public offering of common stock on November 27, 2018.

Asset Management

In 2018, Southwest Gas continued its more than 16-year relationship with a diverse asset manager for the Company's 401k plan.

Leasing Services

Southwest Gas utilizes diverse suppliers, and continues to seek new diverse businesses, for lease financing opportunities. In 2018, Southwest Gas extended a lease agreement with a service-disabled veteran owned business for capital equipment.

Legal Services

Southwest Gas is committed to diversity and inclusion in all aspects of its business, including the procurement of legal services. During 2018, Southwest Gas engaged a woman-owned California law firm to provide legal counsel and expertise involving environmental compliance and related issues with procurement of approximately \$252,000. Supplier Diversity Program Staff is working with the firm to obtain Clearinghouse certification. In addition, the Company continues to provide additional opportunities for women, LGBT and minority attorneys in non-diverse law firms. Several of the women

and minority attorneys who are members/partners of majority-owned law firms, serve as lead counsel representing Southwest Gas in a wide range of legal matters. Southwest Gas remains committed to meeting its legal needs by utilizing women, LGBT and minority-owned attorneys and law firms, and will continue to promote diversity within the legal services field.

Description of Planned Program Activities

Internal Outreach Activities

In 2019, Supplier Diversity Program Staff will continue to develop and refine Program strategies to identify and engage diverse suppliers by focusing on:

- Building on Program successes and enhancing relationships through increased communication and interaction with internal business units;
- Continuing to promote Program awareness and increased outreach opportunities for decision makers;
- Refining Program plans, policies, and procedures to promote the inclusion of diverse suppliers in all bid opportunities;
- Expanding efforts to educate and engage internal stakeholders on LGBTBE goals;
- Increasing focus on Tier 2 spend opportunities through Program awareness and training; and
- Furthering education for internal business units on issues impacting diverse suppliers and offering ensuring payments are made promptly.

External Outreach Activities

- Southwest Gas will strive to meet and exceed the procurement goals set forth in GO 156 and continue to incorporate the requirements of Assembly Bill 1678. For 2019, Southwest Gas set a minimum goal of .50 percent procurement spend for products and services with LGBTBEs.
- Southwest Gas intends to partner with regional organizations and diverse chambers of commerce to identify qualified diverse businesses in lower-utilization areas.
- Southwest Gas will continue its expanded outreach efforts to promote and provide Program information to increase visibility and procurement opportunities for diverse suppliers.

Plans for Recruiting Diverse Suppliers in Low-Utilization Areas

Southwest Gas regularly evaluates procurement activity to identify and evaluate opportunities to enhance relationships with diverse businesses. Program Staff continually works with internal business departments to refine strategies to increase procurement in areas of lower diverse supplier utilization. In 2019, Program Staff will continue to focus on these efforts by:

- Connecting diverse firms and Southwest Gas decision makers at outreach and networking events;
- Enhancing and expanding relationships with diverse businesses in under-utilized spend categories, including LGBT, Native American, and disabled veteran business enterprises;
- Pursuing partnerships with California utilities and developing events targeting diverse procurement in areas of low and under-utilization; and
- Investing and supporting business organizations and chambers of commerce that promote development opportunities for diverse businesses in low and under-utilized areas.

Southwest Gas continues to make strides to identify diverse suppliers in our limited California service territories. In 2019, the Company intends to continue these efforts by extending outreach activities to areas adjacent to the Company's service territories in both Northern and Southern California.

Plans for Encouraging Prime Contractors to Engage Diverse Subcontractors

In 2019, identifying and increasing diverse subcontracting procurement will be an area of focus for Southwest Gas. Program Staff will continue to collaborate with our prime suppliers and internal stakeholders to find expanded opportunities for diverse subcontractors. Program activities will include the following:

- Encouraging prime suppliers to pledge their support to utilize diverse subcontractors by setting a diverse procurement goal;
- Meeting with prime contractors and Supply Chain personnel to develop a plan to identify and track spend with diverse subcontractors;
- Providing necessary assistance and training to prime contractors in identifying and sourcing certified diverse firms; and
- Providing opportunities for prime contractors to connect with diverse subcontractors through workshops and networking activities.

General Order 156 Compliance

Southwest Gas will continue to adhere to the guidelines as established in GO 156 to achieve overall Supplier Diversity Program success and further increase diverse supplier procurement. Southwest Gas will also collaborate with diverse supplier trade organizations to identify qualified diverse suppliers in low and under-utilized areas.



2018 Annual Fuel Procurement Report and 2019 Plan

In 2018, Southwest Gas purchased a total of \$3,271,893 in natural gas supplies from two Clearinghouse-Verified diverse suppliers. The Company purchased \$132,707 of natural gas supplies to support its California operations and \$3,139,187 to supports its Nevada and Arizona operations. Southwest Gas remains committed and steadfast in including diverse businesses in its gas supply solicitations.

Current Market Conditions

The Company's Gas Supply Department secures natural gas supplies to serve the Company's sales customers in California, Nevada and Arizona. The Company meets these requirements through a combination of firm contract purchases, monthly spot market purchases, and daily spot market purchases. The Company purchases gas supplies in the most economic manner from a range of sources and everchanging number of potential suppliers. Southwest Gas acquires the necessary gas supplies on a competitive price basis, also taking into consideration the reliability and assured performance of potential gas suppliers, as well as the reliability of the actual sources of supply. Diverse suppliers have an opportunity to compete directly with the Company's other natural gas suppliers. Southwest Gas has a longstanding commitment to doing business with diverse suppliers and will provide opportunities when possible and economic.

Southwest Gas actively solicits both firm and spot market gas supply offers from diverse suppliers. Whether daily, monthly or long term, the Company encourages diverse suppliers to participate when it seeks offers for natural gas supplies. Generally, Southwest Gas receives responses to its solicitation programs from various diverse suppliers, some of whom become successful in the competitive process.

Outreach Efforts

Southwest Gas reviews proposals from prospective diverse gas suppliers and provides those potential suppliers with information and the opportunity to participate in all bidding programs. Additionally, the Company's Gas Supply Department fields calls directly from prospective suppliers, accepts referrals from industry contacts, and pursues contacts provided by Supplier Diversity Program Staff.

During 2018, Southwest Gas also sponsored a biannual supplier meeting and invited all eligible suppliers, including diverse suppliers to participate. During the supplier meeting, Company representatives provided information and helped educate suppliers on the Company's solicitation processes and how best to become a successful participant in those solicitations. Further, the Company's Gas Supply employees participate in various energy industry organizations, subscribe to numerous industry publications, and regularly engage in industry conferences and workshops. These efforts support and promote the development and maintenance of relationships with diverse natural gas suppliers.

Recruiting Diverse Suppliers in Low-Utilization Areas

In 2018, Southwest Gas purchased natural gas supplies from two Clearinghouse-Verified diverse suppliers in support its California operations and will continue its efforts to increase procurement in areas of low-utilization.
