
**DRIVERED PILOT QUARTERLY REPORT** (see Attachment 1: Cruise Quarterly Report [Drivered])

On February 19, 2020, Cruise received the Drivered Pilot permit from the California Public Utilities Commission ("CPUC"). This pilot allows Cruise to offer drivered rides to members of the public. For this reporting period, Cruise has conducted a total of 814.9 miles of vehicle miles traveled. Included in this total are drivered demonstration rides with members of the public and rides taken by Cruise employees as part of the Employee Early Rider Program. Demonstration rides start and end at the same location and are scheduled rides provided to internal Cruise employees and limited members of the public for the purposes of demonstrating Cruise AV capabilities. Starting on June 28, 2021, Cruise enabled the Employee Early Rider Program under the Drivered Pilot permit. This program allows selected Cruise employees to schedule drivered rides using Cruise's app within the geographic boundaries of Cruise's operational design domain in San Francisco. The hours of operation for this program are 8 pm - 8 am daily.

**DRIVERLESS PILOT QUARTERLY REPORT** (see Attachment 2: Cruise Quarterly Report [Driverless])

On June 02, 2021, Cruise received the Driverless Pilot permit from the CPUC. This pilot allows Cruise to offer driverless rides to members of the public. For this reporting period, Cruise has conducted a total of 463.4 miles of vehicle miles traveled. Included in this total are driverless rides taken by Cruise employees as part of the Employee Early Rider Program. On November 01, 2021, Cruise enabled the Employee Early Rider Program under the Driverless Pilot permit. This program allows Cruise employees the ability to schedule driverless rides using Cruise's app within the geographic boundaries of Cruise's operational design domain in San Francisco. The hours of operation for this program are 11 pm - 5 am daily.
