Item #13 [20451] – Order Instituting Rulemaking to Review Procedures Regarding the Acquisition of Water Utilities Under the Commission's Jurisdiction

Order Instituting Rulemaking to review the existing guiding framework set forth in Decision 99-10-064 (consistent with the Public Water System Investment and Consolidation Act of 1997) regarding acquisitions involving water utilities under the Commission's jurisdiction.

Quasi-Legislative

PROPOSED OUTCOME:

- Opens a new Order Instituting Rulemaking (OIR) to review the existing framework as set forth in Commission Decision 99-10-064 regarding acquisitions of regulated water utilities under the Commission's jurisdiction.
- This OIR seeks to improve and revise the current acquisition process.

SAFETY CONSIDERATIONS:

- There are no immediate safety considerations associated with this decision.
- Improving the acquisition process of smaller regulated water utilities may promote the Commission's safety goals.

ESTIMATED COST:

• There are no costs known at this time.

Item #35 [20477] – Intervenor Compensation to Environmental Defense Fund R.18-12-006

Order Instituting Rulemaking to Continue the Development of Rates and Infrastructure for Vehicle Electrification.

Quasi-Legislative

PROPOSED OUTCOME:

Awards Environmental Defense Fund (EDF) \$39,270.00 for substantial contribution to Decision (D) 20-12-027 and D.20-12-029, which adopted strategies and metrics to further the integration of electric vehicles as electrical grid resources, and fulfills obligations imposed on the Commission by Senate Bill 676. EDF originally requested \$40,717.50.

SAFETY CONSIDERATIONS:

 Substantial contribution by intervenors, as found here, enhances the Commission's ability to resolve safety and other issues under Public Utilities Code Section 451 to take all actions "necessary to promote the safety, health, comfort, and convenience of its patrons, employees, and the public." There are no safety considerations associated with this decision.

ESTIMATED COST:

• \$39,270.00, plus interest, to be paid by the ratepayers of Pacific Gas and Electric Company, San Diego Gas & Electric Company, and Southern California Edison Company.

Order Instituting Rulemaking to Revise General Order 156 to Include Certain Electric Service Providers and Community Choice Aggregators and Encourage Voluntary Participation by Other Non-Utility Entities Pursuant to Senate Bill 255; Consider LGBT Business Enterprise Voluntary Target Procurement Percentage Goals; Incorporate Disabled Business Enterprises; Modify the Required Reports and Audits; and Update Other Related Matters.

PROPOSED OUTCOME:

- Implements Senate Bill 255 (Bradford, Stat. 2019, Ch. 407) to revise the Commission's Supplier Diversity Program in General Order 156 (GO 156) by incorporating community choice aggregators, electric service providers, and additional utilities that meet the statutory revenue thresholds.
- Adopts additional revisions to GO 156, as follows: (1) adds a procurement goal for LGBT business enterprises; (2) adds business enterprises owned and controlled by persons with disabilities; (3) adds workforce and board diversity reporting requirements; and (4) other updates.
- This proceeding remains open.

SAFETY CONSIDERATIONS:

• There are no safety considerations associated with this decision.

ESTIMATED COST:

• There are no costs associated with this decision.

Item #41 [20365] – Self-Generation Incentive Program Heat Pump Water Heater Incentives R.20-05-012

Order Instituting Rulemaking Regarding Policies, Procedures and Rules for the Self-Generation Incentive Program and Related Issues.

Quasi-Legislative

Comr. Rechtschaffen - Judge Fogel

PROPOSED OUTCOME:

- Establishes budgets and program requirements for Self-Generation Incentive Program (SGIP) heat pump water heater (HPWH) incentives.
- Directs gas investor-owned utilities (IOU) (Pacific Gas & Electric Company, Southern California Gas Company, San Diego Gas & Electric Company) to allocate \$40 million from their respective 2023 Capand-Trade allowance auction revenues to fund additional SGIP HPWH incentives.

SAFETY CONSIDERATIONS:

• There are no safety considerations associated with this decision.

ESTIMATED COST:

 Decision (D.) 19-09-027 and D.20-01-021 allocated \$44.7 million towards SGIP HPWH incentives. This decision allocates \$40 million in gas IOU 2023 Cap-and-Trade allowance auction revenues for SGIP HPWH incentives. D.20-01-021 approved collection of \$830 million in revenues for all SGIP incentives through 2025..

Item #42 [20424] – Development of Community Based Organization Pilot to Reduce Energy Utility Customer Bill Debt Accumulated During the Coronavirus Pandemic

R.21-02-014

Order Instituting Rulemaking to Address Energy Utility Customer Bill Debt Accumulated During the COVID-19 Pandemic.

Ratesetting

Comr. Houck - Judge Watts-Zagha

PROPOSED OUTCOME:

- Directs Pacific Gas and Electric Company to convene a Working Group of diverse representation to develop and file proposal for Investor-Owned Utilities' Community Based Organization Arrears Case Management Pilot.
- Directs Investor-Owned Utilities to transform Community Based Organization Network Template into Community Based Organization Database and Map and publish for public consumption.
- Closes the proceeding.

SAFETY CONSIDERATIONS:

• Ensures continuation of essential electricity and gas service to customers subject to service disconnection due to nonpayment of bills.

ESTIMATED COST:

• There are no costs associated with this decision.

Item #44 [20416] – Federal Funding Account Rules R.20-09-001

Order Instituting Rulemaking Regarding Broadband Infrastructure Deployment and to Support Service Providers in the State of California.

Quasi-Legislative

Comr. Alice Reynolds - Judge Glegola

PROPOSED OUTCOME:

- Adopts rules for new broadband Federal Funding Account grant program created by Senate Bill 156 and funded through the federal American Rescue Plan Act of 2021, and the rules issued by the U.S. Treasury Department.
- The Federal Funding Account is a new two-billion-dollar grant program focused on building broadband Internet infrastructure to communities without access to Internet service at sufficient and reliable speeds.
- The rules adopted in this decision include, among other items: project eligibility, application objections, allocating funds between rural and urban counties, and a ministerial review process whereby Communications Division Staff may approve certain applications.
- This proceeding remains open.

SAFETY CONSIDERATIONS:

• Improves safety through more communities and individuals with access to advanced communications.

ESTIMATED COST:

• The program will use already authorized federal funds.
