#### 1.0 INTRODUCTION

This Transformer Oil Processing Nighttime Nuisance and Noise Reduction Plan (Plan or Oil Processing Plan) was prepared for San Diego Gas & Electric Company's (SDG&E) Artesian 230kV Substation Expansion Project (Project). The Plan was prepared to comply with Mitigation Measures (MMs) NV-1, NV-2 and NV-5, as described within the Final Initial Study and Mitigated Negative Declaration (IS/MND) prepared by the California Public Utilities Commission (CPUC) for the Project (CPUC, 2019). It is important to note that this Plan is not applicable to the entire permitted Project; rather it is applicable only to the oil processing of one (1) 230/69kV 224 MVA transformer at the Artesian Substation site. Specifically, this Plan provides a description of SDG&E's process for processing oil into a new transformer, including noise and nuisance reduction and avoidance measures. The Project involves the installation and operation of one 230/69kV 224 MVA transformer, which needs to be filled with transformer oil. The oil processing (i.e., filling of the transformer with oil) requires a limited number of pieces of equipment to operate continuously for four days and three nights, for a total period of up to 84 hours. Since this activity includes equipment operation outside of allowable construction hours for the City of San Diego (i.e., 7:00 am to 7:00 pm, Monday through Saturday), this nighttime noise and nuisance reduction plan is required.

#### 1.1 PROJECT LOCATION

The overall Project components are located between Rancho Santa Fe (to the west) and Poway (to the southeast), in the western portion of San Diego County, with elements located within both the City of San Diego and unincorporated County of San Diego, California (see Figure 1 in Appendix A). The Project (69kV reconductor) route (approximately 2.2 miles) traverses both developed residential and commercial areas. The Project involves facilities located within SDG&E's existing rights-of-way (ROW), franchise positions (city/county roadways), and SDG&E fee-owned properties.

The 230/69kV transformer is located within the East Parcel at the existing Artesian Substation, in the approximate location shown in Appendix B: Photographs. The oil processing procedure will take place at this location.

#### 1.2 PROJECT DESCRIPTION

The overall Project includes the following main components:

- Within SDG&E's existing property, expand and rebuild the Artesian Substation to include a new 230kV substation yard and additional 69kV connections.
- Make minor modifications at the existing Bernardo and Rancho Carmel Substations within the existing substation footprints.
- Loop in existing 230kV transmission line into the new 230kV substation yard at the Artesian Substation.
- Reconductor an existing double-circuit 69kV power line located between the Artesian and Bernardo Substations, including the replacement of existing wood pole structures with new steel pole structures as needed, and removal of certain existing pole structures from service.

#### 2.0 OBJECTIVES

The objective of this Nighttime Noise and Nuisance Reduction Plan is to minimize noise and general nuisance from the proposed oil processing of a new 230/69kV 224 MVA transformer at the Artesian Substation Site, in compliance with the Project's approved Mitigation Measures. The proposed oil processing activities are required prior to operation of the new transformer. Oil processing activities were previously conducted in July 2020 to partially fill the transformer with oil to maintain compliance with the manufacturer warranty. Now that the transformer has been positioned onto its new pad at the existing 69/12kV Artesian Substation, final oil processing activities are required to put the transformer into service.

## 3.0 APPLICABLE REQUIREMENTS

#### 3.1 APPLICABLE MITIGATION MEASURES

All or portions of Mitigation Measures NV-1, NV-2, and NV-5 are applicable to this Plan. These measures are included below in their entirety. Plan Sections 3.3.2 and 4.2 describe how the Project will comply with these MMs.

#### **MM NV-1: Variance Request**

If it is determined that construction activities are necessary during nighttime hours or on a Sunday, SDG&E shall submit a variance request to the County of San Diego and/or City of San Diego planning departments to work outside of allowed construction hours. SDG&E shall provide CPUC with evidence that it has obtained the variance(s) prior to commencing such work.

#### MM NV-2: Construction Noise Reduction Plan 1

Distribute to the potentially affected residences within 100 feet of Project construction a "hotline" telephone number, which shall be attended during active construction working hours, for use by the public to register complaints. All complaints shall be logged noting date, time, complainants' name, nature of complaint, and any corrective action taken.

#### MM NV-5: Nighttime Noise and Nuisance Reduction Plan

SDG&E and/or its contractors shall develop a Nighttime Noise and Nuisance Reduction Strategy Plan in the event that nighttime construction activity is determined to be necessary within 500 feet of sensitive receptors. The plan shall be submitted to the CPUC for review and approval prior to the commencement of nighttime construction activities. The strategy shall include a set of site-specific noise attenuation measures that apply state-of-the-art noise reduction technology to ensure that nighttime construction noise levels and associated nuisances are reduced to the extent feasible. The attenuation measures may

include, but not be limited to, the control strategies and methods for implementation that are listed below.

- Plan construction activities to minimize the amount of nighttime construction.
- Offer temporary relocation of residents within 200 feet of nighttime construction activities.
- Temporary noise barriers, such as shields and blankets, shall be installed immediately adjacent to all nighttime stationary noise sources (e.g., auger rigs, generators, compressors, etc.).
- Install temporary noise barriers that block the line of sight between nighttime activities and the closest residences within 500 feet.
- The notification requirements identified in Mitigation Measure NV-2 shall be extended to include residences within 500 feet of pending nighttime construction activities.

#### 3.2 APPLICANT PROPOSED MEASURES

There are no applicable Applicant Proposed Measures for this Plan.

#### 3.3 OTHER APPLICABLE REQUIREMENTS

In addition to the applicable Project MMs described above, this Nighttime Noise and Nuisance Reduction Plan also addresses other requirements and limitations including a discussion of applicable project components, required permits and agency approvals.

#### 3.3.1 Applicable Project Components

While MMs NV-1 and NV-5 are applicable to any Project construction activities occurring at night, this Plan is intentionally focused to cover only a small aspect of construction for the Project; oil processing for one 230/69kV transformer at the Artesian Substation site (Eastern Parcel). Any other construction activities required to occur at night will require preparation of additional documentation in compliance with the applicable MMs.

#### 3.3.2 City of San Diego Noise Ordinance

The Artesian Substation site is located within the City of San Diego and is therefore subject to the City's Noise Code. The City of San Diego Noise Ordinance prohibits construction activities between the hours of 7:00 p.m. and 7:00 a.m. and on Sundays and legal holidays, except in case of emergency or a permit has been applied for and granted beforehand by the Noise Abatement and Control Administrator (City of San Diego, 2019). In accordance with the Noise Code, SDG&E has obtained a permit to allow for oil processing activities to occur outside of the allowable construction hours, as described in Section 3.3.3, below.

In addition, the City of San Diego Noise Ordinance includes allowable noise limits for different times of day, as described in the table below. The Artesian Substation site, where the oil processing will take place, is surrounded by commercial land uses to the east, multi-family residential land

uses to the south (which are the closest noise sensitive receptors), an SDG&E powerline and transmission line ROW to the west (with single-family residential land uses to the west of the SDG&E ROW), and transportation land uses (Camino del Sur) to the north (with powerline ROW and single-family residential land uses to the north of Camino del Sur).

Considering these adjacent land uses, the applicable nighttime noise limits for the Artesian Substation site are 40 dBA at the single-family residential properties to the west and north, 45 dBA at the multi-family residence to the south, and 60 dBA at the commercial properties to the east. These limits are noted in bold in the table above.

#### 3.3.3 Required Permits and Agency Approvals

In accordance with the City of San Diego Noise Code, SDG&E has obtained a Construction Noise Permit (i.e., temporary variance from the Noise Code) for oil processing activities at the Artesian Substation site to occur outside of allowable construction hours for the City of San Diego (i.e., 7:00 am to 7:00 pm, Monday through Saturday). A copy of the Construction Noise Permit is included in Appendix C of this Plan.

#### 4.0 PLAN IMPLEMENTATION

This section describes the scope and requirements of MMs NV-1, NV-2, and NV-5 as well as the methodologies SDG&E will employ to maintain compliance with these MMs. Specifically, this section includes a description of the transformer oil processing procedure, equipment, timelines, and noise and nuisance avoidance methods used to minimize the disturbance to noise sensitive land uses within 500 feet of the Artesian Substation Site.

#### 4.1 TRANSFORMER OIL PROCESSING PROCEDURE

The transformer oil processing procedure is discussed in the following sub-sections, including both general practices as well as Project specific plans for the processing of transformer oil for the Artesian 230/69kV transformer.

#### 4.1.1 Required Vehicles and Equipment

The transformer oil processing procedure includes the following equipment.

Equipment	Function	Noise Emissions at Night
Oil Processing Rig	Creates vacuum and pumps oil into the transformer.	The oil processing rig includes 2 vacuum pumps and one booster pump, all of which are located within the rig. The oil processing rig is operated during the entire process, although the various pumps are only active during certain portions of the process.
Portable generator	Powers the oil processing rig	The generator has a motor and is operated during the entire process.
Manlift	Utilized to set-up and connect the oil processing rig with the transformer	None – equipment is not operated during nighttime hours
Oil tank	Hold oil during the oil heating and pumping process.	None – the oil tank does not have a motor or any other component that emits noise.
Oil storage rig	Holds oil prior to being heated and inserted into the transformer.	None – the oil storage rig does not have a motor or any other component that emits noise.

#### 4.1.2 Oil Processing Schedule and Timing

The general sequence, timing, and duration of the oil processing procedure is as follows:

- Oil Processing Day 1:
  - 1. Turn on portable generator and oil processing rig (start of day; approximately 7am)
  - 2. Start vacuum process (approximately 10am; vacuum process lasts approximately 24 hours)
- Oil Processing Day 2
  - 1. Vacuum process is complete (approximately 10am)
  - 2. Heat up oil and fill transformer under vacuum (approximately 16 hours)

- Oil Processing Day 3
  - 1. Break vacuum (start of day; approximately 7am).
  - 2. Perform hot oil circulation (approximately 10am; oil circulation lasts approximately 24 hours).
- Oil Processing Day 4
  - 1. Hot oil circulation stops (at approximately 10am) and equipment is demobilized and taken offsite.
  - 2. Oil processing is complete.

#### 4.2 NOISE AND NUISANCE AVOIDANCE AND MINIMIZATION MEASURES

The oil processing activity will use a combination of standard and project-specific measures to ensure that generation of noise and other nuisance to surrounding noise sensitive land uses are minimized to the greatest extent possible, as required by MM NV-5. Based on similar recent operations at other SDG&E substations, SDG&E understands that the noise emissions from oil processing within a walled substation are minimal (Meridian, 2020). Specifically, the following actions will be taken to avoid or minimize noise and nuisance impacts to surrounding land uses:

- 1. Utilize existing or constructed noise barriers where feasible.
- 2. Provide additional noise barrier for the generator.
- 3. Avoid noise sensitive land uses as much as possible.
- 4. Notify residents within 600 feet.
- 5. Limit the work occurring at night as much as possible.
- 6. Limit crew size as much as possible.

#### 4.2.1 Use Existing Noise Barriers








Figure 2: Transformer Oil Processing Site Plan

The existing Artesian 69/12kV substation is surrounded on all sides by a concrete masonry unit (CMU) wall, and on the south side by an additional concrete soil nail wall approximately 20 feet south of the CMU wall. Each wall is 20- to 22-feet tall. The CMU wall would shield noise emissions by the Project in every direction. The soil nail wall provides additional shielding for noise emissions south of the Project. The closest noise sensitive receptor (apartment complex) is located south of these walls. Because of the addition of these walls, and considering the distance to the nearest residences (see Figure 2 in Appendix A), noise emissions from oil processing equipment (portable generator and oil processing rig) are not expected to exceed the City's nighttime noise limits (40 dBA for single family residential properties and 45 dBA for multi-family properties) between the hours of 10 pm and 7 am. These noise level estimates are based on the Roadway Construction Noise Model (RCNM), Version 1.1 (refer to Appendix D):

- 1. Average noise levels (Leq) at the nearest multi-family residential property line (225 feet south of the generator and oil processing rig) are estimated to be approximately 39 dBA.
- 2. Average noise levels (Leq) at the nearest residential structures (310 feet south of the generator and rig) are estimated to be approximately 37 dBA.

3. Average noise levels (Leq) at the single-family residences to the west and north (over 500 feet from the generator and rig) are estimated to be approximately 32 dBA.

#### 4.2.2 Provide Additional Noise Barrier for the Generator

While the existing features at the Artesian Substation, including the existing block substation wall and the adjacent slopes, create a barrier to sound emitted from the oil processing procedure, SDG&E will implement an additional sound barrier for the portable generator to comply with MM NV-5. The generator represents the main source of noise, therefore providing the additional sound barrier for the generator will minimize noise impacts on the multi-family residential structure located south of the substation site. To create the additional sound barrier for the generator, the Oil Processing Rig will be positioned between the generator and the multi-family residential to the south. The generator is approximately 5 feet tall, and 6 feet long whereas the Oil Processing Rig is 12 feet tall and approximately 40 feet long. Therefore, the Oil Processing Rig will effectively block the line of sight between the generator and the multi-family residential complex and provide additional noise reduction in addition to the existing substation block wall and vegetated slope.

#### 4.2.3 Avoid Noise Sensitive Land Uses

The oil processing equipment will be positioned to mitigate any potential noise impacts to the extent feasible. The equipment will be setup as far from sensitive noise receptors as possible to limit the noise impacts, as noise attenuates with distance. In addition, all of the oil processing equipment will be operated within the existing substation walls, further reducing noise emissions that reach nearby noise sensitive land uses.

#### 4.2.4 Provide Nighttime Work Notifications

In compliance with MM NV-5, SDG&E sent out notifications to residents within 600 feet<sup>2</sup> of the Artesian Substation site where the transformer will be delivered. In compliance with MM NV-2, the notices included a "hotline" phone number that the public can use to ask questions or register complaints. SDG&E will create a log of any complaints received and provide a copy of the Complaint Log to CPUC as part of the next Weekly Compliance Summary. Notification Letters went out on February 17, 2021. A copy of the notification letter and mailing list are included in Appendix E.

#### 4.2.5 Limit Work that Occurs at Night

As a standard practice for transformer oil processing, SDG&E conducts all activities during normal construction (i.e., 7am to 7pm) except those steps that must occur during nighttime hours. All activities that can be completed during allowable working hours are done so. Specifically, the activities that will occur at night are limited to the following:

1. Vacuum the transformer (duration approximately 24 hours),

- 2. Oil heating (duration approximately 16 hours), and
- 3. Fill transformer with heated oil (duration approximately 24 hours).

All set-up and breakdown of equipment would occur during normal construction hours.

#### 4.2.6 Limiting Crew Size

The nighttime portions of the transformer oil processing procedure will be completed using a crew that is only large enough to complete/monitor the work. Excess crew, inspectors, and monitors will not be onsite in order to reduce the amount of activity and potential disruption. Support staff will be limited to two personnel who monitor the oil processing procedure.

#### 4.2.7 Noise Monitoring

As requested by the condition of approval, SDG&E will conduct noise monitoring during the oil processing operation to record noise levels at the site of the Artesian Substation. In the event that a complaint from a member of the public is received, data recording actual noise levels associated with the oil processing operation may serve to demonstrate due diligence on the part of SDG&E that measures were taken to accurately represent noise conditions, reduce noise levels to the extent feasible, and thereby address potential neighbor/receptor's concerns adequately.




Photo 1. West-facing view of the transformer on the right, and the nearest residences on the far left (apartment complex south of the project).



The California Public Utilities Commission (CPUC) has granted San Diego Gas and Electric Company (SDG&E®) a Permit to Construct the Artesian 230kV Substation Expansion Project (Project).
