I received your email dated today, May 20, 2020, pertaining to the recent discovery by Bear Valley Electric Service (BVES) of errors in data tables contained in BVES' 2020 wildfire mitigation plan submission.

BVES should serve to the service list of R.18-10-007 a corrected and redlined version of BVES' 2020 WMP; however, given that the Wildfire Safety Division has already conducted its analysis based upon the information that was submitted on February 7, 2020, as updated on March 6, 2020, the Wildfire Safety Division will not be making any updates or changes to its evaluation based on the corrected information. The Wildfire Safety Division will hold BVES accountable to its commitments submitted in its February 7, 2020 WMP submission, as updated on March 6, 2020, and compliance will be measured against the version of the plan evaluated by the Wildfire Safety Division.
