RE: Extension Requests: The Utility Reform Network, Al Stein, Wildfire Safety Division

Dear Ms. Basilio:

On March 16 and 17, 2020, Pacific Gas and Electric Company (PG&E) submitted three (3) letters to the Wildfire Safety Division seeking extensions on several data requests. First, PG&E requested leave to delay its response to The Utility Reform Network's Data Request Set 12, Nos. 1-3 until March 20, 2020. Second, PG&E requested leave to delay its request to respond to Al Stein Data Request 7, Nos. 1-3 until March 27. Al Stein submitted an email in opposition to PG&E's request to the Wildfire Safety Division on March 18, 2020. Finally, PG&E requested leave to delay its response to numerous data requests submitted by the Wildfire Safety Division on March 13, 2020 to March 27, 2020, with the option to request further extensions.

Wildfire Safety Division has reviewed PG&E's requests for extensions and makes the following determinations. (A table containing due dates for each Wildfire Safety Division data request is attached to this letter).

- PG&E must respond to TURN Data Request Set 12, Nos. 1-3 by end-of-day March 20, 2020.
- PG&E must respond to Al Stein Data Request 7, Nos. 1-3 by end-of-day March 20, 2020.
- PG&E must respond to all Wildfire Safety Division data requests with code "I" by end-of-day March 23, 2020.
- PG&E must respond to all Wildfire Safety Division data requests with code "Z" and code "Y" by end-of-day March 27, 2020. Wildfire Safety Division will not grant any further extensions; any missing data will not be considered in the 2020 Wildfire Mitigation Plan evaluation process.

Responses to Wildfire Safety Division data requests should follow the instructions sent on February 26, 2020, as noted below:



- a. Clearly reference the "Item Index" in the response to each data request. This will ensure that utility responses are clearly targeted to specific data requests.
- b. For sections of the WMP where utilities are providing updates to existing text or data, or adding new text or data elements, etc., provide a version of the entire WMP in "track changes" format showing any changes relative to your WMP submitted on February 7. Also provide a version in clean copy.
- c. Updated WMPs must be served on the service list of R.18-10-007. The previously set deadline for PG&E's submission is changed as set forth in the attachment to accommodate responses to this data request.
- d. For data requests that relate to Tables 1 through 31, or any other information provided in excel format, provide an updated version of the relevant table, highlighting cells with modified data in yellow and highlighting cells with new data in green relative to the version submitted on February 7, 2020. For clarity, include a legend in the same excel file. Also provide a separate clean copy in excel format.
- e. Providing a "track changes" version is not applicable to GIS-focused data requests.
- f. For data requests that are not specific to a section of the guidelines, GIS files, or tables, please provide a response to the data request in the cell next to the data request on the excel table. Provide a link to an external document if required.
- g. Provide the files through Kiteworks in a folder labeled "utilityname_DR_20200313" with the "Item Index" and the data request date in the file name.
