Background

Pursuant to the establishment of Senate Bill 350 (de León, Chapter 547, Statutes of 2015) Disadvantaged Communities Advisory Group and the appointment of the advisory group nominees by the California Public Utilities Commission (CPUC), and the California Energy Commission (Energy Commission), the CPUC and the Energy Commission will jointly convene a meeting.

The advisory group advises the two commissions on the effectiveness of proposed programs related to the Clean Energy and Pollution Reduction Act of 2015 (also known as Senate Bill 350) in disadvantaged communities.
