# **CPUC Welcomes New President**

As we enter 2022, the California Public Utilities Commission (CPUC) welcomes a new President!

Governor Gavin Newsom has appointed <u>Alice Busching Reynolds</u> as the CPUC's President. Prior to her appointment, President Reynolds served for three years as Governor Newsom's senior advisor for energy. Prior, she served in the administration of Governor Edmund G. Brown Jr., including as the senior advisor for climate, the environment, and energy. She previously served as chief counsel and deputy secretary for law enforcement at the California Environmental Protection Agency (CalEPA). During her time at CalEPA, she coordinated statewide multi-agency environmental enforcement actions and led the creation of the agency's environmental justice task force and refinery safety task force.

President Reynolds began her public service career in 2002, serving approximately 10 years as a deputy attorney general in the California Attorney General's Office, where she litigated cases involving protection of public trust lands, coastal resources and public access, and other environmental issues.

President Reynolds is proud and excited to join the CPUC and help Californians receive safe, clean, and affordable utility services.

Customers from all parts of Apple Valley Ranchos Water and Park Water service areas are encouraged to participate in the public forums.

In response to Governor Newsom's directive concerning restrictions on public gatherings to protect customers and community members during COVID-19, these public forums (formally called Public Participation Hearings) will not have in-person attendance. Members of the public can view the public forums via the Internet, or listen and make comment by toll-free phone line. Those who would like to make public comment must participate by phone.

You can also make your voice heard in this proceeding, and read the comments of others, on our online Docket Card comment section.

The remote public forums will begin with a brief overview of Apple Valley Ranchos Water and Park Water's requests, then public comments will be heard via phone.

### **CPUC Penalizes PG&E for 2019 Kincade Wildfire**

As 2021 came to a close, the CPUC approved penalties and permanent disallowances against Pacific Gas and Electric Company (PG&E) for violations related to the ignition of the 2019 Kincade wildfire. Under a settlement with the CPUC's Safety and Enforcement Division (SED), PG&E shareholders will pay a \$40 million penalty to California's General Fund and incur an \$85 million permanent disallowance for cost recovery for the removal

of abandoned transmission facilities within its service territory, for a total of \$125 million.

The Kincade wildfire ignited in October 2019 within PG&E's service territory and burned more than 77,000 acres and destroyed nearly 374 structures. SED's investigation into the Kincade wildfire and the involvement of PG&E's infrastructure found multiple violations of General Order 95, a

CPUC regulation that sets safety factors and strength requirements in the design, construction, and maintenance of overhead electrical lines and communications facilities. The settlement addresses the violations through shareholder-funded permanent removal of multiple abandoned transmission facilities within PG&E's service territory.

The settlement is formally referred to as an Administrative Consent Order. This new enforcement tool was created in November 2020, when the CPUC adopted an Enforcement Policy to better serve Californians through streamlined enforcement actions that can be taken by CPUC enforcement staff in lieu of issuing a Citation or seeking a formal Order Instituting Investigation (OII). The addition of these tools to the CPUC's enforcement options in 2020 moved the CPUC's practices more in line with the enforcement practices of many other state and local enforcement agencies.

On July 2, 2021, Liberty Utilities' Apple Valley Ranchos Water Corp. and Park Water Corp. submitted General Rate Case applications requesting CPUC approval to increase rates for water service for 2022-2024. Liberty Apple Valley Ranchos Water is requesting to increase its rate charges for water service by \$2,862,903 (or 11.11 percent) in 2022, \$2,068,273 (or 7.18 percent) in 2023, and \$2,280,637 (or 7.35 percent) in 2024. Liberty Park Water is requesting to increase its rate charges for water service by \$5,475,273 (or 15.1 percent) in 2022, \$1,820,970 (or 4.35 percent) in 2023, and \$1,752,224 (or 4 percent) in 2024. According to the util-

ity, main contributors to the rate increases include increased capital-related costs resulting from increased investments, increases in unit cost of production, anticipated inflationary increases, increases in payroll expense, and increases in health and welfare benefits.
