



The California Public Utilities Commission (CPUC), in ongoing efforts to enhance Pacific Gas and Electric Company's (PG&E) ability to meet its safety obligations, has approved the utility's regionalization plan, which the CPUC ordered PG&E to pursue as a condition of CPUC approval of the utility's bankruptcy plan.

PG&E's service area will be divided into five specific regions: North Coast, North Valley/Sierra, Bay Area, South Bay/Central Coast, and Central Valley. Creating regions is designed to improve the utility's safety activities and local responsiveness.

"The CPUC's bankruptcy decision required regional restructuring so that PG&E would be more present in the community and better able to serve the diverse values and needs of its customers," said CPUC Commissioner Clifford Rechtschaffen. "Regionalization is one of the many ways we are looking to see if PG&E has transformed itself into a safer, more reliable, and more customer serving utility since emerging from bankruptcy two years ago."

The CPUC directed PG&E to hold town hall meetings in the five regions until the completion of the <u>regionalization plan</u> and report to the CPUC on its implementation activities. In addition, a Regionalization Stakeholder Group will be formed to monitor PG&E's performance in the implementation of the regionalization plan.

CPUC Names New Deputy Executive Director for Energy and Climate Policy



n June 20, 2022, Leuwam Tesfai was named the CPUC's Deputy Executive Director for Energy and Climate Policy.

Leuwam previously served as Commissioner Genevieve Shiroma's Chief of Staff and Legal Advisor, a position she held since 2019 when appointed by Governor Gavin Newsom.

Leuwam has worked at the CPUC since 2011 in several roles, including as an

Advisor to former Commissioner Liane M. Randolph and in the CPUC's Legal, Energy, and Administrative Law Judge Divisions.

Leuwam's private sector experience includes renewable energy markets, siting and permitting generation facilities, and commercialization of clean energy technologies. She is a graduate of Emory University and the University of San Francisco School of Law.

The CPUC typically holds <u>Voting Meetings</u> twice a month in San Francisco or Sacramento, and also <u>schedules</u> Voting Meetings periodically in other cities throughout the state to enhance outreach and engagement.

The Voting Meeting begins with public comment, and members of the public are encouraged to attend. Those intending to make public comment can sign-up to speak in person before 11 a.m. Public comment will also be accepted by phone at the number above.

Additional Area Code Comes to 707 Region

n order to ensure that phone numbers continue to be available to meet the demand in the geographic region served by the 707 area code, the CPUC approved a second area code (called an overlay) that will provide additional numbering resources while minimizing customer inconvenience. The new area code to overlay the 707 area code is 369.

The 707 area code, serving portions of Del Norte, Glenn, Humboldt, Lake, Marin, Mendocino, Napa, Solano, Sonoma, Tehama, and Trinity counties, is projected to run out of available prefixes (the first three numbers after the area code in a phone number) by the fourth quarter of 2023.

An area code overlay adds a second area code to the geographic region served by the existing area code. Therefore, multiple area codes co-exist within the same geographic region. Existing 707 customers will retain their area code and specific telephone number(s). Custom-711, and 811.

Below are some tips to help prepare for the area code overlay:

- · Contact security or alarm vendors to update dial-up numbers to avoid a break in security routines and con-
- Reprogram equipment or features, i.e., automatic dial, speed-dial, call forwarding, modems for computer or Internet dial-up access, etc.
- Update items like stationery, checks, etc., to include your area code + telephone number.
- Provide your area code and telephone number, not just the telephone number, as needed.
- When asking for someone's number, remember to ask for the area code, too.
- Remember that the previous area code and the new area code will coexist within the same geographic region.

An area code overlay adds a second area code to the geographic region served by the existing area code.

The 707 area code was created when it split off the 415 area code in 1959. The 707 area code serves the cities of American Canyon, Arcata, Benicia, Calistoga, Clearlake, Cloverdale, Cotati, Crescent City, Dixon, Eureka, Fairfield, Ferndale, Fort Bragg, Healdsburg, Lakeport, Napa, Novato, Petaluma, Point Arena, Rio Dell, Rio Vista, Rohnert Park, Saint Helena, Santa Rosa, Sebastopol, Sonoma, Suisun City, Trinidad, Ukiah, Vacaville, Vallejo, Windsor, Willits, and Yountville. ■



PUBLIC FORUMS SET

for Customers of San Gabriel Valley Water

Remote public forums have been scheduled to provide an opportunity for customers of San Gabriel Valley Water Company to offer their perspective and input to the CPUC about the company's rate increase requests, as follows:

Fontana Water Company division; all commentors welcome

July 11, 2022, 2 p.m. AND 6 p.m.

Los Angeles County division; all commentors welcome

Customers from San Gabriel Valley Water service areas are encouraged to participate in the public forums.

Due to continued concerns about COVID-19, these public forums (also formally known as Public Participation Hearings) will not have in-person attendance. Members of the public can view the public forums via the Internet or listen and make comment by toll-free phone line. Those who would like to make public comment must participate by telephone.

You can also make your voice heard in this proceeding, and read the comments of others, on our online Docket Card comment section.



Each remote public forum will begin with a brief overview by San Gabriel Valley Water explaining the proposed rate changes, followed by a presentation by the CPUC's Public Advocates Office and Fontana Unified School District. Public comments will be taken via phone. At least one representative from San Gabriel Valley Water will be present throughout the forum to answer service or billing customer questions.

The July 7 remote public forums will focus on the proposed rate changes in the Fontana Water Company division. The July 11 remote public forums will focus on the proposed rate changes in the Los Angeles County division. Although each forum will be designated for either division, San Gabriel Valley Water customers are welcome to attend any of the forums, regardless of their service area.

On January 3, 2022, San Gabriel Valley Water submitted its 2023 General Rate Case application requesting CPUC

approval to increase its rates for water service in its Los Angeles County and Fontana Water Company divisions for 2023-2025.

San Gabriel Valley Water is requesting to increase the Los Angeles County division's gross annual revenues by \$10,791,000 (or 13.1 percent) in 2023; \$4,847,000 (or 5.2 percent) in 2024; and \$5,044,000 (or 5.1 percent) in 2025. If San Gabriel Valley Water's rate request for its Los Angeles County division is approved by the CPUC, the average residential monthly bill with a 5% x 3/4-inch meter using 11 cubic feet of water per month would increase by approximately \$5.52 (or 7.7 percent) in 2023, by \$9.54 (or 12.4 percent) in 2024, and by \$4.73 or (5.5 percent) in 2025.

San Gabriel Valley Water is requesting to increase the Fontana Water Company division's gross annual revenues by \$9,202,000 (or 11.3 percent) in 2023; \$5,164,000 (or 5.7 percent) in 2024;

and \$5,281,000 (or 5.4 percent) in 2025. If San Gabriel Valley Water's rate request for its Fontana Water Company division is approved by the CPUC, the average residential monthly bill with a 5% x 3/4-inch meter using 11 cubic feet of water per month would increase by approximately \$4.64 (or 5.9 percent) in 2023, by \$9.29 (or 11.2 percent) in 2024, and by \$4.85 or (5.2 percent) in 2025.

San Gabriel Valley Water supplies water to the general public in the counties of Los Angeles and San Bernadino, serving approximately 97,750 customers.

The CPUC welcomes remote attendance and comments on San Gabriel Valley Water's requests at the public forums, as public comments will help the CPUC reach an informed decision. The Administrative Law Judge assigned to the proceeding is scheduled to issue a Proposed Decision in the case for CPUC Commissioner consideration within a year.
