CPUC TO HOLD SERIES OF PUBLIC PARTICIPATION HEARINGS ON PG&E'S REQUEST TO RAISE RATES

SAN FRANCISCO, July 7, 2016 - The California Public Utilities Commission (CPUC) will hold Public Participation Hearings to hear directly from members of the public about Pacific Gas and Electric Company's (PG&E) request to increase rates. PG&E is requesting CPUC authority to increase revenue \$333 million in 2017, followed by an additional increase of \$469 million in 2018 and, in 2019, an additional increase of \$368 million. The cumulative total increase for the 2017-2019 period would be \$2.305 billion as compared to the 2016 revenue amount of \$7.9 billion.
