## CPUC TO HOLD HEARINGS TO RECEIVE PUBLIC COMMENT ON SECOND PHASE OF PG&E RATE CASE

SAN FRANCISCO, July 18, 2017 - The California Public Utilities Commission (CPUC) is holding Public Participation Hearings to obtain comment from the public about Phase II of Pacific Gas and Electric Company's (PG&E) rate case to determine the cost each customer class is responsible for and to determine the rate schedules for each customer class.
