**PUBLIC UTILITIES COMMISSION REPORT PURSUANT TO
PUBLIC UTILITIES CODE SECTION 321.6****Introduction**

Pub. Util. Code Section 321.6 requires that the California Public Utilities Commission report on the number of formal proceedings where resolution exceeded the time periods prescribed in scoping memos and the number of days that Commissioners presided in hearings. It further requires that the Commission submit the report to the Governor and Legislature no later than February 1 of each year. As described in this report for calendar year 2013, all of the 258 proceedings resolved at the Commission during 2013 were timely. More detailed information is contained in the attached Appendices A-I.

Pub. Util. Code Sections 1701.1 et al. apply to cases filed after 1998 that were subject to hearing at the Commission. These statutes require that matters be resolved within certain time periods, depending on the categorization of a proceeding. Generally, adjudicatory matters must be resolved within 12 months and ratesetting and quasi-legislative matters are to be resolved within 18 months of the issuance of the scoping memo ruling. A proceeding has been resolved when the main issues have been decided such that the proceeding could usually be closed. At times, proceedings that have had all substantive issues decided may remain open or are "re-opened" because of other tangential issues, such as petitions for modifications, various motions, or requests for intervenor compensation.

In addition to data related to proceedings that were subject to hearings, this report contains important case management information on other proceedings as well, in the interest of providing transparency, public access, and statutory compliance.

Description of Attached Appendices A-I**Appendix A – Formal Proceedings not Subject to Hearings, Active During this Reporting Period**

Appendix A lists the 274 cases active during the time period that were not subject to hearings. Many of these proceedings are ratesetting or adjudicatory matters that were conducted without formal evidentiary hearings. Also, this appendix lists 28 quasi-legislative matters that were processed through the exchange of written documents and formal evidentiary hearings were not required.

Of the 274 cases, 178 were resolved timely. The remaining 96 proceedings are currently active and on schedule.

Appendix B – Complaints Under the Expedited Complaint Procedure, Active During the Reporting Period

Appendix B lists 69 Expedited Complaint Proceedings (ECP) that are small complaint cases handled under special procedures analogous to “small claims” court. We are reporting these matters separately because the Commission has adopted more aggressive timelines for these cases than the legislative timelines. The Commission has established an informal 132-day target for this type of proceeding to be resolved.

During the reporting period, 43 of these 69 cases were resolved. All 43 resolved matters met the 12 months legislative mandate. Twenty six proceedings remain active.

Appendix C – Formal Proceedings Subject to Hearings, Active During the Reporting Period – Proceedings Resolved on Schedule

During the reporting period, the Commission timely resolved 32 (23 ratesetting, one quasi-legislative, and eight adjudicatory) proceedings subject to evidentiary hearings.

Appendix D – Formal Proceedings Subject to Hearing, Active During the Reporting Period – Proceedings not Resolved on Schedule

All formal proceedings subject to hearing resolved during the reporting period were timely. This is the fourth consecutive year, since the reporting period was initiated in 1998, that the Commission has achieved 100% compliance with the legislative deadlines for proceeding resolution and processing.

Appendix E – Formal Proceedings Subject to Hearing, Currently Active and on Schedule

Appendix E contains cases subject to hearing that are not yet resolved and currently still active. There are 174 such cases – 36 adjudicatory, four quasi-legislative and 134 ratesetting. All of these cases are currently on schedule.

Appendix F – Petitions for Rulemaking

Petitions for Rulemaking are statutorily mandated proceedings subject to the deadlines in Pub. Util. Code Section 1708.5. The Commission is mandated to issue a decision in this type of proceeding within six months. Appendix F shows that nine such proceedings were active during the reporting period and that the Commission has timely issued proposed decisions on five of the petitions, and the remaining four petitions are on schedule.

Appendix G – Commissioner Attendance

Appendix G reports the Commissioner attendance at hearings during the period. The table shows that Commissioners attended 43 days of hearings and presided during 23 of those 43 days.

Appendix H – 60-90 Day Compliance

The Legislature has also established guidelines for the length of time between the issuance of a proposed decision and the adoption of a final decision by the Commission, applicable to ratesetting and quasi-legislative proceedings requiring a hearing. The guidelines are either 60 or 90 days depending on certain circumstances.

During the period, the Commission considered 29 proposed decisions in proceedings subject to these guidelines. The Commission adopted 23 final decisions in such proceedings. In 19 instances, the final decision was adopted within the guidelines and in four instances, the final decision was issued later than the period specified in the guidelines. Six proposed decisions are currently on the Commission's agenda.

Appendix I – Issuance of Presiding Officer Decisions and Proposed Decisions

For proceedings that require a hearing, the Legislature has also established guidelines for the length of time between the submission of a matter for decision and the issuance of the proposed decision. During the period, the Commission issued eight presiding officer decisions and 26 proposed decisions in such proceedings. Out of these 34 decisions, 22 (65%) we issued within the mandatory 60-day and 90-day timelines. During 2013, the Administrative Law Judge Division reached a historic low of only 33 full-time judges and given our current docket of over 350 open formal proceedings, we do not foresee being able to achieve better results meeting the guidelines until we are fully staffed at 40 full-time judges.

Conclusion

In summary, this report, submitted in compliance with Pub. Util. Code Section 321.6, provides the public and the legislature information on the timeliness of Commission action in formal proceedings. Specifically, 558 proceedings were active at the Commission during the 2013 reporting period. All of the 258 proceedings resolved during 2013 were timely. This is the fourth consecutive year, since the reporting periods were initiated in 1998, that the Commission achieved 100% compliance with the deadlines for proceeding resolution. The Commission is committed to continuing to achieve full compliance with the mandatory statutory deadlines, transparent and accessible proceedings and procedures, and will work toward compliance with the statutory guidelines.
