# **Preliminary Consensus**

- Confidential vs. Public

- Public Report
  - Aggregated data, average costs per space
- Agreement on general template format
  - Data reported for each year of Program
- Common Costs (Direct) vs. Utility-specific costs
  - Identified on Template
- Disadvantaged Communities
  - Number of spaces, % of total converted

- Pre-conversion Leak Survey
- What are the necessary CARE Tiers
- Beyond the Meter expense if <u>not covered</u>?
- Construction milestone dates per project?
- Total Number of MHPs
  - Participating, Completed, Opted-Out.
- Total Program Per-Space Cost
  - Gas, Electric, Both.
- Other Electric Impact Data Table 7


# Cost Distribution (SED- proposed)

- To show the variability of project costs
  - Report as a Histogram
  - Distribution of Cost/Space for each project
  - No identification of individual projects

### **HCD Involvement**

- Post-Conversion Inspections
- Routine Inspection Programs
  - 5% of all MHPs per year
  - Complaint response: problem-specific



# **HCD Electrical Inspection**

### Park System

- Overhead Support Poles
- Weatherproof Equipment
- Equipment clearly marked
- Conduit protection of conductors

### Mobile Homes

- Power Cords (in home)
- Feeder Assemblies (external)
- Wiring Methods (conduit)
- Access to service equipment
- Home grounding

- Other proposed criteria?


