Application of Safety Management Systems and Standards in Utility Safety

The Commission's Office of the Safety Advocate (OSA) will facilitate a Safety En Banc with CPUC Commissioners on Safety Management Systems (SMS).

SMS and SMS Standards have been developed and employed by a number of industries and companies to improve safety. An employed SMS may conform to recognized standards. Such standards often encompass common safety "pillars" or elements, which may include:

*Leadership	*Stakeholder Engagement	*Safety Culture
*Risk Management	*Operational Controls	*Safety Assurance
*Quality Assurance	*Investigation/Root Cause Analysis	*Documentation
*Training	*Management of Change	*Management Review

The purpose of this En Banc is to examine and share information among regulatory staff, utilities, and industry and academic experts, about how SMS and SMS Standards may be employed to improve utility safety. The focus of this En Banc will be the gas and electric industry.
